1. Apologies:

Apologies and feedback received from Cllr Annemieke Waite (North Somerset Council).

2. Update of monies committed in 2024:

An updated total was provided to the committee members.

3. Correspondence:

Since the previous meeting we have received two letters of gratitude from previous successful organisations:

Churchill Music and the Primary Schools received a grant to provide educational sessions to
the student. The organisation would like to thank the Committee as the children have
learned how they can use music to benefit their health and wellbeing particularly living close
to a busy airport. The class teacher said - "The positive powers of music were clearly and

imaginatively communicated and the children enjoyed recalling them during the second session. The children enjoyed the mix of information and active participation in a range of ways. We would highly recommend the Power of Music team to other schools."

Backwell Playing Fields Charity were awarded funding to help provide and improve drainage
and year-round access to the play facilities. The charity said that the high-traffic areas under
the play equipment are no longer mud baths, as the rubber mulch covers the surfaces while
allowing water to drain through.

4. Applications for funding:

Diamond Fund

Whiteoak Way School Association

This project requested £1,000 for a grant from the Diamond Fund for funding towards purchasing sports kit and equipment for the school.

The project is within close proximity to the Airport and meets the criteria of the Fund. The committee supported this project and were happy to grant £1,000 towards the project.

Resolved: A grant of £1,000 is approved by the committee.

Bristol Bears Community Foundation

The Bristol Bears Community Foundation requested £1,000 for a grant to go towards financially supporting a toilet facility so children, young adults and adults with disabilities and additional needs can use on Bristol Bears match days.

This project was not supported as the committee members felt the location was not in close proximity to the Airport.

Resolved: A grant will not be awarded to this group.

Holly Hedge Animal Sanctuary - Barrow Gurney

This project requested £150 from the Diamon Fund to create a wildlife haven /mindfulness garden

and mini allotment for staff and volunteers to use as a quiet space for breaks and partake in some

gardening.

The project is within close proximity to the Airport and meets the criteria of the Fund. The

committee supported this project and were happy to grant £150 towards the project.

Resolved: A grant of £150 is approved by the committee.

Clevedon Cricket Club

This organisation applied for a grant of £1,000 from the Diamond Fund to purchase outside furniture

suitable for older and/or disabled spectators. The project is within close proximity to the Airport and

meets the criteria of the Fund. The committee supported this project and were happy to grant a

£1,000 towards the project.

Resolved: A grant of £1,000 is approved by the committee.

Nailsea Tithe Barn Trust: Memories at the Barn - Supporting Local People with Dementia

This organisation applied for a grant of £1,000 from the Diamond Fund to help with the transport

costs of using the Nailsea Community Bus to those living in the local community with dementia.

The project is within close proximity to the Airport and meets the criteria of the Fund. The

committee supported this project and were happy to grant £1,000 towards the project.

Resolved: A grant of £1,000 is approved by the committee.

Nailsea & District Community Transport

This organisation applied for a grant of £1,600 from the Diamond Fund to purchase eight minibus

vehicle trackers to help reduce fuel and overall costs. The project is within close proximity to the

Airport and meets the criteria of the Fund. The committee supported this project and were happy to

grant a contribution of £1,000 towards the project.

Resolved: A grant of £1,000 is approved by the committee.

Winscombe RFC U16s Girls Rugby Club

Winscombe RFC U16's Girls Rugby Club requested £928.50 from the Diamond Fund for a team

building day for the group of girls which would include lunch and an archery session at Mendip

Activity Centre.

This project was not supported as the committee members felt the location was not in close

proximity to the Airport.

Resolved: A grant will not be awarded to this group.

Dolphin Society

This organisation applied for a grant of £1,000 from the Diamond Fund to help towards the yearly

cost of the maintenance of the pendant alarms for financially disadvantaged, isolated, elderly people

who fear falling and being unable to call for help.

The project is within close proximity to the Airport and will help support residents in the North

Somerset area. Also, this project meets the criteria of the Fund. The committee supported this

project and were happy to grant £1,000 towards the project.

Resolved: A grant of £1,000 is approved by the committee.

Cheddar Cricket Club

This organisation applied for a grant of £1,000 from the Diamond Fund to help towards the cost of

installing a new artificial cricket pitch. This project was not supported as the committee members

felt the location was not in close proximity to the Airport.

Resolved: A grant will not be awarded to this group.

Bristol Bridge Club - Redland

This organisation applied for a grant of £1,000 from the Diamond Fund to renovate their community

building and improve access for disabled visitors or those in poor health / elderly.

This project was not supported as the committee members felt the location was not in close

proximity to the Airport.

Resolved: A grant will not be awarded to this group.

Somerset International Festival of the Arts (SIFA)

The Somerset International Festival of the Arts organisation applied to the Diamond Fund for a grant

to provide unique transformative musical experiences through education and outreach projects

across North Somerset.

The organisation applied for £2,000 to help deliver educational sessions to the following schools -

Wrington C of E Primary School; St Andrews Primary School, Congresbury; Chestnut Park Primary

School, Yatton; Education Workshop at St Andrew's Church, Backwell.

The project is within close proximity to the Airport and will help pupils in the North Somerset area.

Also, this project meets the criteria of the Fund. The committee supported this project and were

happy to grant £2,000 towards the project.

Resolved: A grant of £2,000 is approved by the committee.

Yatton RFC Under 7's

This organisation applied for a grant of £807 from the Diamond Fund to help towards the cost of

purchasing kit bundles for the young rugby players which includes tops, shorts, socks & hoodies.

The project is within close proximity to the Airport and meets the criteria of the Fund. The

committee supported this project and were happy to grant a contribution of £807 towards the

project.

Resolved: A grant of £807 is approved by the committee.

Sporting Weston Football Club

This organisation applied for a grant from the Diamon Fund of £535.23 towards the cost of

purchasing footballs, training bibs, crowd barrier and pop-up goals for the football team that play at

the King George V Playing Field, Cleeve.

The project is within close proximity to the Airport and meets the criteria of the Diamond Fund. The

committee supported this project and were happy to grant a contribution of £535.23 towards the

project.

Resolved: A grant of £535.23 is approved by the committee.

Homeland - Backwell

This organisation applied for £1,000 from the Diamond Fund to pay towards the creation of the

therapeutic arts studio at their site.

Whilst this project is situated within close proximity to the Airport, it did not meet the criteria of the

Fund. Therefore, the committee members did not approve this project.

Resolved: A grant will not be awarded to this group.

Burrington Parish Room Limited

This project applied for £1,000 for a grant from the Diamond Fund to help pay for the repairs to the

Burrington Parish Room, which includes improvements to the main roof and the kitchen fire escape

doors.

The project is within close proximity to the Airport and meets the criteria of the Fund. The

committee supported this project and were happy to grant a contribution of £1,000 towards the

project.

Resolved: A grant of £1,000 is approved by the committee.

Wellspring Counselling

This organisation applied for £4,800 from the Diamond Fund to provide low-cost 1:1 counselling to

anyone in North Somerset over the age of 11. The charity offers a person-centred approach to

mental health support, tailoring their services to each client's needs.

The project is within close proximity to the Airport and will help residents in the North Somerset

area. Also, this project meets the criteria of the Fund. The committee supported this project and

were happy to grant a contribution of £1,200 towards the project.

Resolved: A grant of £1,200 is approved by the committee.

5. **Noise Overview**

Whitney Love informed the committee members on the 2024 Noise Mitigation Scheme (NMS),

programme. The following was presented to the committee members:

Scheme went live first week of April. Two application periods for 2024:

Beginning of April – 1st of June

Beginning of July – 1st of September

For the 2024 Noise Mitigation Scheme (NMS), £200,000 has been budgeted. The previous scheme

required a 50% contribution for some noise bands. This is no longer the case.

In total, there have been 27 applications received this year with a total cost totalling £142,053.52.
